- Actively participate with Engineering on future facility projects, ensuring projects fall within Keyera's Process Safety Management guidelines.

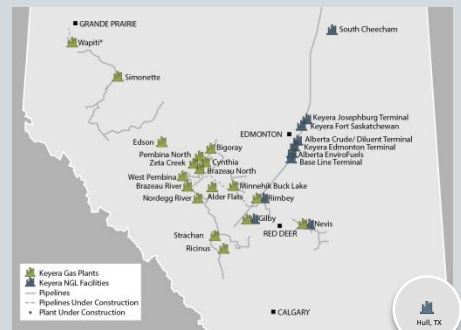
